- 1) I was not notified, nor do I have any records to indicate that peoplefinder.net was a problem, nor do I have any reference to relays.osirusoft.com's last zone file. Perhaps if an actual IP address was given, I could provide more information. I have asked for this information on several occasions.
- 2) No internal document suggested any reference to peoplefinder.net. Perhaps if I had an IP address, as requested verbally, I could work with such information to help answer your question.
- 3) There was no such assertion, nor was there any reference to peoplefinder.net in any internal document.
- 4) My filtering system for mail I use works with IP addresses, not domains. There are occasional references to domains, but no such reference exists. Are you sure peoplefinder.net was ever in my local filters?
- 5) I have no information about Pallorium's disclosed domains. My filters are IP address based. Perhaps if you could provide an IP address I might be able to find information about it.
- 6) Again, I have no information about pallorium's domains.

- 9) I don't believe the question has relevance, due to the fact that I see no information that shows your network was listed. If spam originated from a network, the originating IP or a cidr mask of such IP was added to my filters. <http://www.spews.org>, <http://www.spamhaus.org>, <http://spamsites.org>, <http://www.spambusters.com.ar> and others have documented procedures. The problem with your question is that I am not sure if the listing you are referring to relates to my personal list or that of a list imported from another site.
- 10) Under normal circumstances, I simply corrected the error.

1 11) If a listing was either automatically added or manually added, and was  
2 inaccurate, I simply removed the entry. If it was a remote list that was  
3 imported into my zone file, I suggested to the import zone that there was  
4 a problem.

29 were not operational during the same time as [relays.osirusoft.com](http://relays.osirusoft.com) was not

1 operational, because Osirusoft's Parent DNS servers were ddos'd. This is  
2 how the ddos attack was designed, to destroy Osirusoft's network.

4 29) Many people harassed me by voice over listings not entered by me. What  
5 may be confusing to understand, is that other than open relays, the only  
6 list maintained was that of a personal list, which Had no reference to the  
7 plaintiff and was roughly 5% of the size of the other import zones.

9 31) Such information is unavailable, as I no longer have that data.

10 32) I built relays.osirusoft.com to complement my own personal use of my  
11 mail servers, so that I could personally filter incoming unsolicited email  
12 AKA "spam". Others simply accessed the same data I did, or downloaded the  
13 zone file and used local servers to reduce the load from my site's already  
14 overloaded system.

15 33) Said phone call was well over a year ago and due to extenuating  
16 circumstances both in my business and with the ddos attack, I'm pretty  
17 sure I didn't have patience for either of you. I believe you demanded  
18 that I remove your company's alleged listing, to which I replied that I  
19 could not access my system, due to a dos attack. At this point, you said  
20 you were going to sue me, so I saw no point in continuing the  
21 conversation. At the point prior to hanging up, I may have said, "See you  
22 in court". I doubt much more was said, simply because I wouldn't have  
23 wasted more than a minute on such a threatening call, as these calls are  
24 common, especially from spammers.

25 34) I designed my system to take input data from text files either locally  
generated or downloaded from other sites, and from my open relay database  
to provide answers via DNS for a given IP A.B.C.D

If D.C.B.A.relays.osirusoft.com or other subzones returned a 127.0.0.X

1 value, my own mail servers would reject email from that site.

2 I do not know what others were doing with the data, but assume others used  
3 it for similar purposes, or simply to flag email as potential Spam. At no  
4 time did I grant permission nor deny access to the data from my name  
5 servers, and at no time was anyone charged for access to my servers, nor  
6 was there any business relationship with said individuals and companies.  
7 Relays.osirusoft.com was a hobby well before the existence of Osirusoft  
8 Research & Engineering and is actually a completely separate non-entity.  
9 At one time, <http://www.osirusoft.com> ( <http://68.167.168.130/osirusoft> )  
10 had mention of relays.osirusoft.com but only to redirect individuals to  
11 the correct site.
